RP13-351-000 – Transco filed rate changes resulting from a change in the 3rd party rates underlying Rate Schedule S-2. The filing was made in Docket No. RP13-351-000. The proposed effective date of the tariff section is December 1, 2012.

RP12-91-000 - On November 9, 2012, Transco filed its annual Penalty Sharing Report for the year ending July 31, 2012 in Docket No. RP12-91-000.

RP13-187-000 – Transco filed rate changes resulting from a change in the 3rd party rates underlying Rate Schedules GSS and LSS. The filing was made in Docket No. RP13-187-000. The proposed effective date is November 1, 2012.

[10-17-2012 – Clarification and Update of Tariff Records](#)

RP13-165-000 – Transco submitted a filing to update and correct certain provisions included in Transco's Fifth Revised Volume No. 1 Tariff. The proposed effective date of the revised tariff records is December 1, 2012.

RP11-2619-000 – Transco filed its annual cash-out report and its report of cash-out refunds for the annual period August 1, 2011 through July 31, 2012 in Docket No. RP11-2619-000.

RP12-1127-000 – Transco filed its Annual LNG Fuel Tracker filing in Docket No. RP12-1127-000. The tariff records contained in the filing are proposed to be effective November 1, 2012.

[09-27-2012 – Order 587-V Compliance Filing](#)

RP12-1076-000 – Transco submitted its filing to comply with Order No. 587-V which adopted Version 2.0 of the NAESB Standards. Included in the Version 2.0 standards are new and revised standards supporting (1) gas-electric interdependency, (2) Capacity Release redesign, (3) Electronic Delivery Mechanism, (4) Customer Security Administration Process, (5) pipeline postings of information regarding waste heat, and (6) minor technical revisions. Transco has requested that the revised tariff records be effective December 1, 2012.

RP12-993-000 – On August 31, 2012, Transcontinental Gas Pipe Line Company, LLC filed a general Section 4 rate filing in Docket No. RP12-993-000 with the Federal Energy Regulatory Commission (Commission). The proposed effective date of the filed tariff records is October 1, 2012. If the tariff records are suspended for the maximum suspension period, the effective date will be March 1, 2013. RP12-932-000 – Transco submitted a filing to clarify and update certain provisions included in Transco's Fifth Revised Volume No. 1 Tariff. The proposed effective date of the revised tariff records is September 8, 2012.

RP11-2400-000 – Transco's GSS LSS Customers Share of Dominion Transmission's Inc. ("DTI") Penalty Revenue for 2012.

[08-03-2012 – Market Area Pooling Rate Filing](#)

RP12-925-000 – Transco filed tariff records to implement its Market Area Pooling proposal. The tariff records are to be effective October 1, 2012. The proposal was filed for on February 14, 2012 and approved by Commission Letter Order on April 12, 2012.

[08-01-2012 – Negotiated Rates Filing](#)

RP12-916-000 – Transco filed tariff records that summarize two service agreements that contain negotiated rates under Rate Schedule FT between Transco and Carolina Power & Light Company, LLC d/b/a Progress Energy Carolinas, Inc. and Transco and the City of LaGrange, Georgia. The negotiated rates will be effective September 1, 2012, the anticipated in-service date of Phase 1 of Transco's Mid-South Expansion project.

[08-01-2012 – Mid-South Expansion Intial Rates Filing](#)

RP12-910-000 – Transco filed rates for its Mid-South Expansion Project. The effective date of the rates are September 1, 2012, the projected in-service date of the project.

[07-31-2012 – S-2 Tracker Filing](#)

RP12-902-000 – Transco filed revised rates for Rate Schedules S-2 pursuant to the tracking provisions under Section 26 of the General Terms and Conditions. The filing tracks rate changes to storage services purchased from Texas Eastern Transmission, LP under its Rate Schedule X-28. The proposed effective date of the tariff record is August 1, 2012.

[06-14-2012 – OBA Compliance Filing](#)

RP12-801-000 – Transco submitted a filing to comply with the Commission's "Order on Rehearing" in Docket No. RP11-2371. As required by that order, Transco is modifying its tariff to state that if Transco negotiates an OBA that is not subject to the cash-out penalties provided for in Section 37 of the General Terms & Conditions of Transco's Tariff, then any such OBA must be excluded from refunds of cash-out surpluses attributable to the Section 37 cash-out mechanism. The proposed effective date of the tariff record is July 15, 2012.

[05-11-2012 – New Rate Schedule FTP](#)

RP12-731-000 – Transco filed a new rate schedule, Firm Transportation - Production Area (FTP), to provide an optional firm service on Transco's Mobile Bay Lateral for buyers who commit to transport gas reserves produced from Outer Continental Shelf blocks for the life of the reserves. Rate Schedule FTP has a volumetric rate, subject to a minimum throughput requirement, and allows buyers to change their transportation contract quantity over time. The submitted tariff records are proposed to be effective June 11, 2012.

RP12-727-000 – Transco filed tariff records reflecting changes to track fuel retention percentage changes attributable to storage and transportation services purchased from National Fuel Gas Supply Corporation under its Rate Schedule SS-1 the costs of which are included in Transco's Rate Schedules LSS and SS-2. The proposed effective dates of the tariff records are June 1, 2012.

RP12-726-000 – Transco filed tariff records reflecting changes to track rate changes attributable to storage and transportation services purchased from National Fuel Gas Supply Corporation under its Rate Schedule SS-1 the costs of which are included in Transco's Rate Schedules LSS and SS-2 and its Rate Schedule X-54 the costs of which are included in the rates and charges payable under Transco's Rate Schedule SS-2. The proposed effective dates of the tariff records are May 1, 2012.

RP12-676-000 – Transco filed tariff records in compliance with ordering paragraph (B) of the April 2, 2012 order which directed Transco to file revised tariff records modifying Section 8.3 of Rate Schedule WSS-Open Access to require that each time Transco purchases replenishment base gas, it either make a limited section 4 filing to recover the cost of that gas or make an informational filing detailing the volume of replenishment base gas purchased and the cost of that gas.

RP12-669-000 – Transco submitted a filing on April 30, 2012 in Docket No. RP12-669-000 to the Federal Energy Regulatory Commission to update its system map and the Zone 3 map in its Fifth Revised Volume No. 1 Tariff. The revised maps reflect the sale of certain assets located on its Central Louisiana lateral effective December 1, 2011. The proposed effective date of the tariff record is May 31, 2012.

RP12-612-000 – Transco filed tariff records reflecting the annual adjustment made by National Fuel to Transco's storage inventory under National Fuel's Rate Schedule SS-1 related to transportation purchased by Transco under National Fuel's Rate Schedule X-54. Transco uses the services it purchases under National Fuel's Rate Schedules SS-1 and X-54 to provide service to its customers under Rate Schedule SS-2. The proposed effective date of filed tariff records is May 1, 2012.

RP12-369-000 – Transco gave notice that the Bayonne Delivery Lateral Project facilities went in-service on April 5, 2012.

[03-30-2012 – Releasable Secondary Capacity Filing](#)

RP12-571-001 – Transco filed an amendment to a filing submitted earlier today in Docket No. RP12-571-000. The purpose of the amendment filing is to correct the effective date on the proposed tariff records to August 1, 2012.

RP12-571-000 – Transco filed to add provisions to its tariff to allow its firm shippers to release secondary firm capacity. The revised tariff provisions are proposed to be effective August 1, 2012.

[03-30-2012 – Negotiated Rates Filing](#)

RP12-556-000 – Transco filed three tariff records that summarize negotiated rate Eminence storage service agreements between Transco and Atlanta Gas Light Company, Transco and Pivotal Utility Holdings (Elizabethtown Gas), and Transco and Virginia Natural Gas. The tariff records are proposed to be effective April 1, 2012.

RP12-486-000 – Transco submitted a filing to clarify and update certain provisions included in Transco's Fifth Revised Vol. No. 1 Tariff. The proposed effective date of the tariff records is April 14, 2012.

RP12-475-000 – Transco filed to revise certain provisions in Sections 2, 18, and 25 of the General Terms and Conditions of its tariff in order to define and clarify current business practices with respect to "swing supplier" transactions on its system. The revised tariff provisions are proposed to be effective April 6, 2012.

RP12-441-000 – Transco filed revised Electric Power rates pursuant to Section 41 of the General Terms and Conditions of Transco's FERC Gas Tariff. The proposed effective date of the tariff sections is April 1, 2012.

RP12-405-000 – Transco filed its Annual Fuel Tracker Filing. The proposed effective date of the tariff records is April 1, 2012.

RP12-383-000 – Transco submitted on February 16, 2012, a filing in Docket No. RP12-383 to remove the Interruptible Transportation Service Rates Applicable to Certificated Transportation Rendered Pursuant to Section 7(c) of the Natural Gas Act and other references to certificated interruptible X-Rate Schedules from its Fifth Revised Volume No. 1 Tariff. The proposed effective date is March 18, 2012.

RP12-382-000 – Transco filed a supplement to its Docket No. RP12-382 filing submitted on February 14, 2012. In the February 14 filing, Transco mistakenly asked the Commission to issue an order on or about March 1, 2012 or as soon as feasible thereafter. Transco intended to request that the Commission issue an order on the February 14 filing on or about March 16, 2012 or as soon thereafter as feasible.

RP12-382-000 – Transco submitted a filing on February 14, 2012 in Docket No. RP12- proposing, on a prospective basis, to change the assessment of transportation usage rates and fuel for transactions leaving the Station 165 and Station 210 pooling points. If the filing is accepted by the Commission as proposed, Transco will implement the changes approximately six months following a final Commission order.

RP12-377-000 – Transco submitted, in Docket No. CP12-14, a request for abandonment of compression service under Rate Schedule X-122 and transportation service under Rate Schedules X-143, X-224 and X-227. In letter order dated January 31, 2012, the Commission approved the abandonment of the rate schedules. In compliance with the approval, on February 10, 2012, Transco filed, in Docket No. RP12-

377, to notify the Commission of the cancellation of Rate Schedule X-122, effective December 31, 1998 and Rate Schedules X-143, X-224, and X-227, effective January 31, 2012, from its FERC Gas Tariff, Volume No. 2. Transco also filed to delete the rate schedules from the Volume No. 2 Table of Contents included in its FERC Gas Tariff, Fifth Revised Volume No. 1, effective January 31, 2012.
