Atlantic Sunrise Project (CP15-138-005)

On November 14, 2018, Transco submitted an Application to Amend the Atlantic Sunrise Certificate, in which Transco requested authorization to allow any of the existing compressor units at Compressor Station 605 and Compressor Station 610 to be operated above their currently certificated horsepower, provided that the total horsepower utilized at Compressor Station 605 not exceed the station's total certificated horsepower of 30,000 horsepower and that the total horsepower utilized at Compressor Station 610 not exceed the station's total certificated horsepower of 40,000 horsepower. FERC issued a Notice of Application on November 21, 2018.

Gulf Connector Expansion Project – Initial Recourse Rates (Docket No. RP19-299-000)

On November 19, 2018, Transco filed tariff records to establish the initial recourse rates for the Gulf Connector Expansion Project. In addition, the filing transmittal letter addresses the assessment of Transco's Zones 1, 2, and 3 fuel retention percentages on gas transported in Zones 1, 2, and 3, stating that, beginning with the in-service date of the Gulf Connector Expansion Project, Transco will begin assessing its generally applicable fuel retention on all gas transported in those Zones, regardless of the direction of flow.

Rate Schedule GSS & LSS Tracker Filing (RP19-163-000)

On November 29, 2018, the Commission approved Transco's October 31, 2018 filing to revise tariff records in order to track third party rate changes attributable to storage services purchased from Dominion Transmission, Inc. The effective date of the revised LSS and GSS rates is November 1, 2018.

Rate Schedule LSS & SS-2 Tracker Filing (RP19-166-000)

On November 29, 2018, the Commission approved Transco's October 31, 2018 filing to revise tariff records in order to track third party rate changes attributable to storage services purchased from National Fuel Gas Supply Corporation Transmission, Inc. The effective date of the revised LSS and SS-2 rates is November 1, 2018.

Rate Schedule LSS & SS-2 Tracker Filing (RP19-208-000)

On November 29, 2018, the Commission approved Transco's October 31, 2018 filing to revise tariff records in order to track third party rate changes attributable to storage services purchased from National Fuel Gas Supply Corporation Transmission, Inc. The effective date of the revised LSS and SS-2 rates is November 1, 2017, April 1, 2018 and May 1, 2018.

Rate Schedule S-2 Tracker Filing (RP19-328-000)

On November 29, 2018, Transco filed a revised tariff record in order to track rate changes attributable to storage services purchased from Texas Eastern Transmission, LP under its Rate Schedule X-28 which are included in the rates and charges payable under Transco's Rate Schedule S-2. The effective date of Transco's revised S-2 rates is December 1, 2018.

Rate Schedule S-2 Refund Report (RP19-350-000)

On November 30, 2018, Transco submitted for filing a Report of Refund to Transco's Rate Schedule S-2 Customers for amounts received in Texas Eastern's OFO Penalty Disbursement Report in Docket No. RP18-1192-000. The amount of penalty and interest Transco distributed to its S-2 customers was \$5,606.70.
