

# **Nomination Changes** 1Line, EDI, & Flat File

*Effective Mid 2018*

#### > The Atlantic Sunrise project will introduce two additional lines in Zone 6:

- The Central Penn Line North (CPLN) will be off the Leidy Line, East of station 517, and extending north.
- The Central Penn Line South (CPLS) will be located off the Leidy Line, East of station 517, and extending south to the mainline at the River Road location.
- As a result of the new lines, a **nomination element, "ROUTE"** will be required.

#### > Shipper's Rights:

- Existing Firm Shippers in Zone 6 will have secondary rights on <u>Central Penn Line South and Central</u> <u>Penn Line North</u>.
- Atlantic Sunrise shippers will have secondary rights on the <u>Leidy Line and Mainline</u> outside the contract path.

#### > What else do I need to know?

- EDI and Flat File format is changing as a result of the new route option. To ensure EDI works, this will require customer testing.
- There will be changes to the nominations page subject to the Rec/Del locations.






## Atlantic Sunrise






### **Capacity Currently In-Service**

## **River Road Location**

- > River Road will be classified as a <u>Transfer</u> location.
- > Transfer locations do not have tolerances.
- > Transfer locations are balanced starting in the timely cycle.
- > Shippers delivering to the transfer location will need to reference their market's contract in the Dn K field.
- > Shippers receiving at the transfer location will need to reference their supply's contract in the Up K Field.

## Changes to 1Line for Nominations in Zone 6 Effective Mid 2018



#### > Nominations


- With three possible routes on the Central Penn Line, Leidy Line, or Mainline, shippers receiving from or delivering to Zone 6 will need to designate their route, if applicable.
- A NAESB nomination element ROUTE will be required for affected Zone 6 transactions.
  - NAESB WGQ Standard 1.4.1 Nominations
  - Element is Business Conditional (BC)

#### > Route Option Rules

- Route Option will <u>not apply</u> to nominations with Receipts and Deliveries in Zone 1 through Zone 5 or in a Zone 6 area that does not require a route.
- Route Option will be required if your Receipt/Delivery locations fall in Zone 6 where route options are available.
- 3 Directional Routes:
  - Non-CPLS Transaction moves **ON** the Mainline or Leidy Line
  - South-CPLS Transaction moves **DOWN** the Central Penn Line South to the Mainline
  - North-CPLS Transaction moves <u>UP</u> the Central Penn Line South to Leidy Line








#### Changes to 1Line for Nominations in Zone 6 Route Options will display based on the Nomination Path


- > <u>Route option will not apply</u> to nominations with Receipts and Deliveries in Zone 1 through Zone 5 or in a Zone 6 area that does not require a route.
  - Example 1: Nomination Path (St 65 to AGL) No change





### Changes to 1Line for Nominations in Zone 6 Route Options will display based on the Nomination Path


- > Route option will be required if your Receipt/Delivery locations fall in Zone 6 where route options are available.
  - Example 2: Nom Path (Grugan to BG&E)








## Example 2 (a) – Non-CPLS






## Example 2 (b) – South-CPLS






## Example 3 (a) – Non-CPLS

### Capacity Release- "Route Option"

- > "Route Option" will be available on Capacity Release pages concurrent with in-service date of the new Atlantic Sunrise CPLS line (including if early in-service is offered down that line).
- > Only certain Secondary capacity releases of FT contracts potentially have the Route option (not applicable to any Primary releases).
  - Route Option is available if any portion of a Secondary release's path crosses any corners of the "ASR Triangle" in Zone 6.
    - Route Options
      - Non-CPLS Transaction moves **ON** the Mainline or Leidy Line
      - South-CPLS Transaction moves **DOWN** the Central Penn Line South to the Mainline
      - North-CPLS Transaction moves <u>UP</u> the Central Penn Line South to Leidy Line
- > Atlantic Sunrise contracts will <u>not</u> have the Route Option for any capacity release transactions.
- > Re-releases of secondary capacity do not have Route Option (they inherit the rights of the releasing contract)
- > Route option is displayed on the TCR when applicable to the release.



## EDI and Flat File Changes for Nominations

### > **EDI**

- The <u>ROUTE</u> element will be available in Flat File and EDI X12 with the implementation of the Atlantic Sunrise full Project targeted for Mid 2018.
- Transco will be working with all EDI shippers to implement changes to the flat file templates and EDI X12
  - Updated Flat Files will be provided for shippers.
  - EDI X12 Testing will need to take to place for updated changes.
  - Testing will take place in April.
- Transco <u>Strongly Recommends</u> that all EDI Shippers and Flat File users participate in testing
  - Major risk of not testing: EDI nominations will <u>NOT</u> validate successfully at the time of implementation.
