Introduction

This module provides information about the MDQ Validation process when submitting nominations in 1Line. 1Line now automatically validates Firm Contract MDQ from the **Retrieve Nominations** page when a nomination is submitted.

MDQ vs Error Hyperlink

When a user is exceeding MDQ, 1Line will show the nomination status as submitted and have a blue **MDQ** hyperlink. This is shown by the screenshot on the left. Often times when submitting a nomination, 1Line may reject a nomination due to an error. When this is the case, 1Line will show the nominations status as Rejected and have a red **Error** hyperlink. This is shown on the screenshot on the right. In the event where a collection of nominations have a mixture of errors and MDQ violations, nominations with errors will be displayed first followed by any MDQ violations.

Some nomination(s) were rejected with errors. To review errors click Error link on selected nomination. Some nomination(s) are over MDQ. To review, click MDQ link on selected nomination.

Once your nomination(s) is submitted you can view the segment(s) where you are exceeding MDQ by clicking the blue MDQ hyperlink. Once you click on the hyperlink, a popup modal will appear indicating the segment(s) where you have exceeded MDQ.

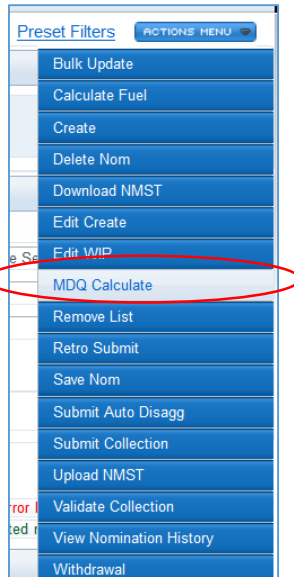
MDQ Calculate

1Line offers the option to view the MDQ of your submitted nominations through the MDQ Calculate Page.

Note: The MDQ Calculate page is driven by the filters set on the Retrieve Nominations page. For example, if you would like to see the MDQ for a particular contract enter that contract ID in the Svc Req K filter. If you would like to see the MDQ for all contracts leave the Svc Req K filter blank.

To **view the MDQ** of a particular contract, or of all contracts from the Retrieve Nominations page:

- 1) Select desired filters
- 2) Click **Retrieve**
- 3) **Actions Menu > MDQ Calculate**



MDQ Segment List Page

The **MDQ Calculate** page offers several viewing options. The **default** setting is **MDQ Segments Exceeded**. To select a different view option click on the associated radio button. The page will automatically refresh with that view displayed. A brief description of the filters and viewing options are provided below.

Filters

- **Check to exclude Zero Nominations from Segment Splits** - when checked in conjunction with any view option, indicates that zero nominations will not be displayed. A zero nomination is one with a nominated quantity of zero, and is not the same as no nomination. For example, if this box is *not* checked, and the option "Display Only Segments in Nomination Paths" is selected, some segments displayed may show a zero in the Nominated column, while segments with no nominations at all, will not be displayed.
- **Show PDA in MDQ calculation**- when checked, PDAs are included with the nominations in the MDQ calculation.

Viewing Options

- MDQ Segments Exceeded** - (default view) displays those segments in which the contract's MDQ is exceeded. If no MDQ violations are found, the page will initially be blank.
