Transco Technical Working Group

On December 15, 2020, the Technical Working Group ("TWG") reported on the progress of the various sub-committees. The next TWG meeting will be held on January 19, 2021 at 1pm CST.

Cash-Out Price Changes (Docket No. RP20-614-001) and Disposition of Cash-Out Costs and Revenues (Docket No. RP20-618-001)

On December 23, 2020, Transco filed an unopposed motion to extend the procedural schedule, and the Chief Administrative Law Judge granted the request on December 28, 2020. This extends the hearing date from March 15, 2021 to April 14, 2021 and the Initial Decision from August 16, 2021 to September 15, 2021.

Order Granting Clarification/Request for Rehearing (Docket No. RP20-1111-001)

On December 2, 2020, Transco submitted a filing in compliance with the Commission's November 16, 2020 order, which revised Section 49 of the General Terms and Conditions to state that Transco will post on 1Line the best bid, the successful bidder, and the Net Present Value analysis used to determine the successful bidder within 3 business days following the close of an open season and award of capacity. On December 16, 2020, the Commission approved the filing, and the tariff record is accepted effective January 2, 2021.

On December 16, 2020, Transco filed a request for rehearing of the Commission's November 16, 2020 Order Granting Clarification.

Rate Schedule S-2 Tracker Filing (Docket No. RP21-336-000)

On December 28, 2020, Transco filed a revised tariff record, pursuant to tracking provisions under Section 26 of the General Terms and Conditions of Transco's Tariff. The revised tariff record was filed in order to track rate changes attributable to storage services purchased from Texas Eastern Transmission, LP under its Rate Schedule X-28 which are included in the rates and charges payable under Transco's Rate Schedule S-2. The effective date of the proposed tariff revisions is December 1, 2020. PLEASE NOTE: Transco will be filing to amend the S-2 Tracker Filing in early January 2021.

Southeastern Trail Project In-Service Request (Docket No. CP18-186-000)

On December 11, 2020, the Commission granted Transco's November 19, 2020 request, as supplemented on December 10, 2020, to place back into service Units 11 and 12 and the piping modifications at Compressor Station 165 in Pittsylvania County, Virginia, associated with the Southeastern Trail Project. On December 23, 2020, the Commission granted Transco's December 9, 2020 request, as supplemented on December 21, 2020 and December 22, 2020, to place Units 13 and 14 at Compressor Station 165 into service and to commence full service of the Southeastern Trail Project as early as January 1, 2021.
