Transco Technical Working Group

On October 20, 2020, the Technical Working Group (“TWG”) reviewed committee expectations and discussed proposals and concepts prepared by both Transco and the customer groups. The next TWG meeting will be held on November 17, 2020 at 1pm CST.

Cash-Out Price Changes (Docket No. RP20-614-001) and Disposition of Cash-Out Costs and Revenues (Docket No. RP20-618-001)

On October 1, 2020, a group of participants jointly filed an Unopposed Motion to Extend the Procedural Schedule to allow additional time for settlement. On October 2, 2020, the Chief Judge issued an order granting the extension.

Rate Schedule SS-2 Tracker Filing (Docket No. RP20-1217-000)

On September 25, 2020, Transco submitted revised tariff records to track rate and fuel changes attributable to transportation service purchased by Transco from National Fuel under its Rate Schedule X-54, the costs of which are included in the rates and charges payable under Transco’s Rate Schedule SS-2. The tariff records are proposed to be effective September 1, 2020.

Cash-Out Surcharge Filing (Docket No. RP21-24-000)

On October 1, 2020, Transco submitted its Initial Cash-Out Surcharge filing. Pursuant to the proposed revisions set forth in Section 15 of the General Terms and Conditions of Transco’s tariff that were filed on February 28, 2020, in RP20-618, and motioned into effect on September 2, 2020, Transco will file to be effective every November 1, a surcharge or refund rate designed to recover from or return to customers amounts in the Cash-Out Deferred Account. On October 30, 2020, the Commission accepted and suspended the tariff records to be effective November 1, 2020, subject to refund and the outcome of the Cash-Out proceedings.

Leidy South Initial Recourse Rates (Docket No. RP21-51)

On October 9, 2020, Transco submitted tariff records to establish the initial recourse rates for the Leidy South Project, in accordance with Commissions July 17, 2020 “Order Issuing Certificates and Approving Abandonment.” The tariff records are effective the later of November 11, 2020, or on the date the Leidy South Project facilities are placed into service.

Penalty Revenue Sharing Report (Docket No. RP21-84)

On October 22, 2020, Transco distributed penalty sharing amounts collected during the annual period ending July 31, 2020 to all affected shippers pursuant to Section 54 of the General Terms and Conditions of Transco’s Tariff.

Southeastern Trail Project In-service Request for Compressor Station 175 (Unit 1) (Docket No. CP18-186)

On September 25, 2020, Transco submitted a request for authorization to partially return existing Compressor Station 175 (Unit 1), which was modified as part of the Southeastern Trail Project, to service on October 5, 2020. On September 30, 2020, the Commission issued a letter order granting Transco's request.

Southeastern Trail Project Amended Initial Rate Filing (Docket No. CP18-186)

On September 30, 2020, Transco filed a request to amend the Southeastern Trail Project initial recourse rates. On October 21, 2020, the Commission approved the amended rate sheets, effective November 1, 2020.

Southeastern Trail Project In-Service Request for Compressor Stations 175 (Unit 2) and 185 (Docket No. CP18-186)

On October 13, 2020, Transco submitted a request to place Stations 175 (Unit 2) and 185 back into service and commence partial firm transportation on November 1, 2020. On October 26, 2020, the Commission issued a letter order granting Transco's request.

Leidy South Notice to Proceed Request for Compressor Station 605 Modifications (Docket No. CP19-494)

On October 9, 2020, Transco submitted its request for authorization to begin modifications to Compressor Station 605 under the Leidy South Project. On October 14, 2020, the Commission issued a letter order granting Transco's request.

Leidy South In-service Request for Compressor Station 605 (Docket No. CP19-494)

On October 22, 2020, Transco submitted a request to place Compression Station 605 back into service at its previously certificated levels, and also to utilize partial path interim service upon completion of the Compression Station 605 software upgrades associated with the Leidy South Project. On October 27, 2020, the Commission issued a letter order granting Transco's request.

Leidy South Notice to Proceed Request for Compressor Stations 607, 610, and 620 (Docket No. CP19-494)

On October 29, 2020, Transco submitted its request for authorization to begin construction of Compressor Stations 607 and 620, and to begin upgrades to Compressor Station 610 associated with the Leidy South Project. In addition, Transco submitted a variance request in the same filing to utilize an existing graveled area as an additional contractor yard for Compressor Station 610. On November 2, the Commission issued a letter order granting Transco's requests.
