North Padre Island Lateral Abandonment (Docket No. CP26-4-000)

On October 8, 2025, Transco filed an application pursuant to section 7(b) of the Natural Gas Act and Part 157 of the Commission’s regulations for its North Padre Lateral (“NPI”) Abandonment Project (“Project”). The Project consists of the abandonment of Transco’s NPI Lateral facilities extending from approximately 3.5 miles from shore, Offshore Texas, to Transco’s Mainline A in Brooks County, Texas. The Commission issued a notice of application on October 23, 2025. The deadline for filing a motion to intervene is 5:00 p.m. Eastern Time on November 13, 2025.

Galveston Block Area 239 to High Island Area Block 154 Abandonment Project – Environmental Assessment (Docket No. CP25-546-000)

On October 15, 2025, the staff of the Commission prepared an EA for Transco’s Galveston Block Area 239 to High Island Area Block 154 Abandonment Project (“Project”). The EA concluded that the proposed Project qualifies as a categorical exclusion under the Commission’s regulations.

Annual Cash-Out Report Supplement (Docket No. RP25-1162-000)

On October 21, 2025, Transco filed a supplement to its Annual Cash-out Report filed in Docket No. RP25-1162.

Annual Cash-Out OUB Surcharge Filing (Docket No. RP26-3-000)

On October 22, 2025, the Commission issued an order accepting Transco’s October 1, 2025 filing to reduce the Original Under Recovery Balance (OUB) surcharge rate from \$0.00067 to \$0.00000.

Initial Rate Filing for Commonwealth Energy Connector Project (Docket No. RP26-6-000)

On October 22, 2025, the Commission issued an order accepting Transco’s October 1, 2025 filing to establish the initial rate for Transco’s Commonwealth Energy Connector Project (CEC). The tariff records are proposed to be effective on November 1, 2025.

Commonwealth Energy Connector Project (Docket No. CP22-502-000) - Authorization to Commence Service

On October 23, 2025, the Commission approved Transco's October 1, 2025 request to place into service the Commonwealth Energy Connector Project and commence service by November 1, 2025.

Northeast Supply Enhancement Project - Implementation Plan Filing (Docket Nos. CP17-101-007 and CP20-49-001 et al.)

On October 25, 2025, Transco submitted its implementation plan pursuant to the Commission's Order Issuing Certificate on May 3, 2019, and Reissued Order Issuing Certificate on August 28, 2025, for the Northeast Supply Enhancement Project.

Annual Penalty Sharing Report (Docket No. RP26-96-000)

On October 29, 2025, Transco filed a Revenue Sharing Report of Penalty Dollars for the annual period ending July 31, 2025. The amount of penalty and interest shared was \$1,024,457.66.

Offer of Settlement for Rate Case (Docket No. RP24-1035-004)

On October 29, 2025, Transco filed the "Stipulation and Agreement" with the Federal Energy Regulatory Commission in Docket No. RP24-1035. The "Stipulation and Agreement" resolves all issues in the proceeding.

Southeast Supply Enhancement Project: Notice of Availability of the Environmental Assessment (Docket No. CP25-10-000)

On October 31, 2025, the staff of the Commission prepared an environmental assessment ("EA") for Transco's Southeast Supply Enhancement Project ("Project"). The Project is an expansion of Transco's existing natural gas transmission that will enable Transco to provide 1,596,900 dekatherms per day of incremental firm transportation capacity in the southeast United States. The deadline for comments is 5:00 p.m. Eastern Time on December 1, 2025.
